

1 MILLION CENT SCHOLARSHIP TERMS AND CONDITIONS

Promotion

1. These terms and conditions relate to and govern the 1 Million Cent Scholarship promotion operated by Education New Zealand (ENZ) (Promotion).
2. In these terms and conditions, a reference to “you” or “your” means the person entering into the Promotion (the Entrant).
3. The Promotion is open to:
 - A. Non-New Zealand residents aged 18 years or over who wish to study or who are currently studying, and wish to continue studying, in New Zealand; and
 - B. Parents and/or guardians of non-New Zealand residents aged 13 years of age or over who wish to study or who are currently studying, and wish to continue studying, in New Zealand.
4. The Promotion opens on 7 July 2017 and closes at 5pm NZT, 20 July 2017.

Prize

5. Through the Promotion ENZ will offer a scholarship worth up to NZD\$10,000 towards study in New Zealand (Prize) to:
 - A. an Entrant; or
 - B. the Entrant’s child or ward aged 13 years or over, nominated by the Entrant (Nominee).
6. The scholarship comprising the Prize will include tuition costs and course-related costs (as applicable) at a New Zealand educational institute of the Entrant’s choice, up to a value of NZD\$10,000, provided that the requirements of these terms and conditions (including the eligibility criteria set out at 21, 22 and 23) are met to ENZ’s satisfaction.
7. ENZ will pay up to NZD\$10,000 directly as a lump sum payment to the New Zealand educational institute on behalf of the winner before 30 June 2018. Transport to and from New Zealand, accommodation, any applicable taxes



payable to the relevant New Zealand educational institute and all other costs and expenses associated with using the Prize are the sole responsibility of the Entrant.

Selection Process

8. In order to be eligible to enter the Promotion, you must:
 - A. be a follower of ENZ's Facebook page as at 20 July 2017;
 - B. be aged 18 years or older as at 20 July 2017; and
 - C. be a resident of a country other than New Zealand.

9. In order to enter the Promotion, the Entrant must post a comment on ENZ's 1 Million Cent Scholarship post on ENZ's Facebook page in accordance with the instructions given in that post by 5pm NZT on 20 July 2017 (an Entry).

10. Each Entrant may only submit one Entry.

11. ENZ will randomly select in its sole discretion a short list of 10 Entries (Short List).

12. ENZ will then:
 - A. contact each Entrant on the Short List privately via Facebook Messenger; and
 - B. require each Entrant on the Short List to complete a form to provide ENZ with further details, including their or the Nominee's intentions to study in New Zealand, education background (for eligibility, see paragraphs 15 and 21 to 27 of these terms below) and further personal details, including photographs (Form).

13. To continue in the Promotion, an Entrant on the Short List must respond to ENZ by filling out the Form, such response to be received by ENZ by the date and time specified on the Form.

14. ENZ will, in its sole discretion, select one Entrant as the winner of the Prize (Prize Winner) based on the information provided by each Entrant or Nominee on the Short List on the Form.

15. ENZ will take a number of factors into consideration in selecting the Prize Winner, including, without limitation, the Entrant's or Nominee's:
 - A. education background;



- B. intention to study in New Zealand; and
- C. ability to study in New Zealand.

16. The Prize Winner will be notified by ENZ through the contact details they provide on the Form by 1 August 2017. ENZ's decision is final and no correspondence will be entered into.
17. The Prize Winner may not receive a cash credit for the value of the Prize and the Prize is not transferrable. If the value of the tuition costs and course-related costs for the Prize Winner's chosen course is less than NZD\$10,000, the Prize Winner is not entitled to the difference in value between NZD\$10,000 and the actual tuition costs and course-related costs.
18. ENZ reserves the right not to offer the Prize, if, in its sole discretion, it is unable to select a suitable Entrant to take up the Prize who meets ENZ's eligibility criteria (see paragraphs 21, 22 and 23 of the terms below).

Obligations

19. By entering the Promotion you agree to:
 - A. maintain, at all times, a responsible attitude to the Promotion and Prize;
 - B. comply with all applicable laws and regulations;
 - C. comply with Facebook's relevant terms of use and policies, including its Community Standards available at <https://www.facebook.com/communitystandards> and Terms of Service available at <https://www.facebook.com/legal/terms>;
 - D. consent to and enable ENZ to contact you via Facebook Messenger for the purposes of facilitating the Promotion;
 - E. comply with any reasonable directions or guidelines ENZ may give you from time to time; and
 - F. not engage in any conduct that may, or is likely to, cause damage to, adversely affect, bring into disrepute, scandalise or ridicule the good name, reputation or image of ENZ or Immigration New Zealand.
20. ENZ reserves the right to remove your Entry and disqualify you from participation in the Promotion at any time if ENZ considers, in its sole discretion, that you have not met your obligations under clause 19.

Eligibility

21. To be eligible for selection as the Prize Winner, an Entrant must:



- A. be aged 18 years of age or older as at 20 July 2017;
 - B. be available to participate in the Prize by taking up or continuing a course of study at a New Zealand educational institute of at least three months' duration;
 - C. be able to cover, at the Entrant's own cost, transport to and from New Zealand, accommodation, and all other relevant costs and expenses associated with using the Prize; and
 - D. be able to obtain, or continue to hold, at the Entrant's own cost, an appropriate student visa to enable the Entrant to stay legally in New Zealand to use the Prize for at least three months.
22. If the Prize Winner is a parent or guardian who nominates a Nominee to take up the Prize, the Nominee must:
- A. be 13 years of age or older as at 20 July 2017;
 - B. be available to participate in the Prize by taking up or continuing a course of study at a New Zealand educational institute of at least three months' duration;
 - C. be able to cover, at the Entrant's or the Nominee's own cost, transport to and from New Zealand, accommodation, and all other relevant costs and expenses associated with using the Prize; and
 - D. be able to obtain, or continue to hold, at the Entrant's or the Nominee's own cost, an appropriate student visa to enable the Nominee to stay legally in New Zealand to use the Prize for at least three months.
23. To be eligible to receive the scholarship comprising the Prize (to be paid directly to the relevant New Zealand educational institution on the Prize Winner's behalf before 30 June 2018), the Prize Winner (or Nominee, if clause 22 applies) must first, before 30 June 2018:
- A. either:
 - 1. have a confirmed offer of place at a New Zealand educational institute; OR
 - 2. be an existing student of a New Zealand educational institute; and
 - B. have obtained, at the Entrant's own cost, an appropriate student visa; and
 - C. provide ENZ with details of their intended study programme (which must be of at least three months' duration).
24. If an Entrant or Nominee provides incorrect or incomplete information ENZ reserves the right to withdraw their Entry.
25. ENZ reserves the right to disqualify a Prize Winner if ENZ considers, in its sole discretion, that the Prize Winner:
- A. has breached any of these terms (including, without limitation, if the Prize Winner does not satisfy one or more of the eligibility criteria listed at 21 or 22);
 - B. has provided incorrect or incomplete information to ENZ; and/or



C. is unable to participate in and use the Prize to ENZ's satisfaction.

- 26. Officers and employees of ENZ, and their immediate family members, are ineligible to enter the Promotion.**
- 27. ENZ reserves its right to remove any person from contention for winning the Prize for any reason and at any time.**
- 28. ENZ is not obligated to provide the Prize to the Prize Winner if the Prize Winner is not able to claim or use the Prize, for any reason.**

Permissions

- 29. If you are selected on the Short List or as the Prize Winner, you hereby irrevocably authorise ENZ (and in the case of an Entrant acting on behalf of a Nominee, will procure that the Nominee consents) to:**
- A. publish your (and/or the Nominee's, as applicable) name and photograph on the ENZ website and Facebook page in connection with any content regarding the Promotion;**
 - B. take photographs and film you (and/or the Nominee, as applicable) during the Promotion process and/or Prize (Promotional Material); and**
 - C. use the information contained in the Promotional Material for ENZ's promotional activities including on social media and for facilitating the Promotion.**
- 30. By entering the Promotion you:**
- A. agree that all of the intellectual property and other rights in and to your Entry, the contents of the Form and the Promotional Material are the exclusive property of ENZ; and**
 - B. irrevocably provide all waivers and consents (and in the case of an Entrant acting on behalf of a Nominee, will procure that the Nominee provides all waivers and consents) to allow ENZ (as well as its agents, affiliates and related government entities) to use your Entry, the contents of the Form, and the Promotional Material for ENZ's promotional activities including on social media and facilitating the Promotion.**
- 31. This competition is governed by the laws of New Zealand and the use of personal information is governed by the Privacy Act 1993.**



32. You agree that the collection, use, storage and disclosure of the personal information that you provide to ENZ in relation to the Promotion is subject to ENZ's privacy policy (www.studyinnewzealand.govt.nz/on/in/privacy).

Liability

33. To the fullest extent permitted by law ENZ will not be liable for any loss or damage whatsoever (including but not limited to indirect or consequential loss) or for personal injury as a result of your participation in the Promotion and/or the Prize.
34. You agree to indemnify, and keep indemnified, ENZ against all claims, demands, costs (including legal costs on a solicitor and client basis), losses, expenses and damages arising out of your participation in the Promotion and/or the Prize.
35. If any act, omission, event or circumstance occurs which is beyond the reasonable control of ENZ and which prevents ENZ from complying with these terms and conditions, ENZ will not be liable for any failure to perform or delay in performing its obligations.
